## HEARING NOTICE

The Salem City Council will hold a public hearing at 6:00 p.m., Monday, August 26, 2024, for the purpose of considering adoption of Ordinance Bill No. 9-24, regarding amendments to Chapter 70 (Utilities) and Chapter 71 (Stormwater) of the Salem Revised Code (SRC). The primary purpose of the proposed amendments is to meet the requirements of the City's Municipal Stormwater Discharge Permit by amending post-construction requirements for new development and redevelopment projects. The criteria applicable to the proposal are set forth in SRC 110. Written statements, including any objection or remonstrance, may be filed with the City Recorder, 555 Liberty Street SE, Room 225, Salem, Oregon 97301, prior to 5:00 p.m. on Monday, August 26, 2024. After to the close of the hearing, a notice of decision will be mailed to all neighborhood associations, anyone who participated in the hearing, and anyone who has requested to receive notice. Prior to the hearing, any person may review the file. A copy of the staff report will be available no later than 5:00 p.m. on August 19, 2024, at the Salem City Hall in the Customer Service Center, 555 Liberty Street SE, Room 100. A copy will also be available at the Salem Public Library, 585 Liberty Street SE, Salem. Copies of the ordinance may be picked up at the Customer Service Center on request. The staff report will also be available online no later than 5:00 p.m. on Friday, August 23, 2024, at: <https://salem.legistar.com/Calendar.aspx>.
